- I will have completed the following courses at UCSD by the end of the 2017 summer session:
  - CHEM 6A, 6B, 6C & 7L or 7LM
  - CHEM 140A, 140B, 140C 143A & 143B
  - MATH 20A, 20B, 20C, 20D
  - PHYS 2A, 2B, 2C (or 2D) & 2CL
  - BILD 1 & 2
  - CHEM 92 (1-Unit Undergraduate Pharmacology Seminar)
- I have an overall GPA of 3.5 or greater.
- I have planned my schedule to complete all of the UCSD Pre-pharmacy requirements by the end of summer session 2017.
- I will have completed all of my undergraduate college's general education and my chemistry major requirements by the end of summer session 2017.

If you checked all eight of the above items, you are eligible to apply for this program.

**In addition to completion of this application form, you must apply to the Pharm.D. Program by completing:**

- 3.) pay all necessary application fees to PharmCAS and UCSD.

**Your PharmCAS and UCSD Supplemental Application materials and Supplemental fee payment/fee waiver must be completed by midnight September 1, 2016 to be considered.**

Your application to this program must include two letters from faculty in the UCSD Department of Chemistry and Biochemistry who can attest to your academic performance. A third letter should be from a person who can attest to your knowledge and/or experience related to pharmacy. **These letters must be submitted through the PharmCAS system.**
