## The Great San Diego Smokeout: A Great Success!

On November 15th, 35 student pharmacists from the UC San Diego Skaggs School of Pharmacy & Pharmaceutical Sciences (SSPPS) reached out to over a thousand people all over San Diego County. The Great San Diego Smokeout was a joint outreach event hosted by APhA/CPhA and CSHP-UCSD, modeled after the American Cancer Society's Great American Smokeout (GASO). The GASO happens annually, every third Thursday of November, and aims to help smokers either quit smoking or help them set a quit date. The goal of our Great San Diego Smokeout event, which

was held a week before the GASO, was to educate the people of San Diego County about the harmful effects of smoking and to promote the GASO so that people who were interested in quitting could seek appropriate help. Students and pharmacist preceptors were stationed at one of ten pharmacy sites throughout San Diego and were either next to the pharmacy or outside the store with a tri-fold poster, brochures, samples, and goodies to hand out. We were lucky enough to collaborate with a few student pharmacists from the University of Southern California's School of Pharmacy, as they helped us spread awareness in Los Angeles.

### GenerationRX - Apha

Over the summer of 2013, the new GenerationRX project chair, Deborah Kim, and the previous project chair, Francis Wang, met to revise the GenerationRX facilitator's guide. The aim was to create a guide that would allow more time for in-depth discussion, skit preparation, and a subsequent Q&A session. In the past, GenerationRx presenter's were pressed for time at many of the presentations. There was a concern that with the time shortage, vital portions of the presentation were being rushed. Though much of prescription drug abuse education lies in the discussion section, solidifying that newfound knowledge lies in the skit portion of the presentation. The skit is the student's time to collect what he or she has learned and apply it to simulated but realistic situations that they could find themselves in. With this understanding, it was crucial that the presentation highlight these two sections and that the presenters interact and convey a strong and solidified messaged. In October, after the start of the new school year, Deborah and Francis held an hour and a half-long training session. In total, 45 APhA-ASP members were trained for Generation Rx. The training session not only covered the facilitator's guide, familiarizing the presenters with the material they would be presenting, a portion of the training session was also dedicated to covering methods and techniques involved in presenting to high school students.

At the end of October, GenerationRx was invited by APhA to present a workshop at the APhA Midyear Regional Meeting held in Denver, Colorado. Deborah Kim and former Project Chair, Greg Estep presented on behalf of GenerationRx. This workshop covered the varying techniques and focal points the UCSD chapter of GenerationRx had implemented over the past year, highlighting what our chapter had done differently. Over the summer, Deborah and Francis attended the San Diego Prescription Drug Action Task Force (PDATF) quarterly meeting to form a partnership with others members of the community who were also involved in the prevention of prescription drug abuse. PDATF is comprised of law enforcement officers, school district administrators, teachers, mothers, and other advocates of prescription drug abuse prevention. GenerationRx partnered with this entity to strengthen the collaborative bond with the community of San Diego aimed towards understanding and fighting against prescription drug abuse. In November at the next quarterly meeting, Deborah and Francis returned to present on GenerationRx and its community work in educating high school students on the dangers of prescription drug abuse. The goal for the upcoming year is to maintain this partnership and to remain involved with the PDATF and the collaborative effort against this growing concern.

In November and December, GenerationRx had its first events of the school year at Kearny High School of Science, Connections and Technology and Mira Mesa High School. In total 21 GenerationRx members reached a total of around 250 students using the new curriculum.

## Outreach at New Tzu-Chi Office

Tracy Nguyen, Medical Assistant, came with two enrollees, followed by Thi Le and Animole Francis, a new Tzu Chi volunteer. Yi Liu, post doctorate from UCSD and Nick Vu, SSPPS pharmacy student joined Peggy Joh and other Tzu-Chi members. Binh welcomed all and stated the purpose of the outreach. Peggy spoke of the mission of Tzu Chi, which was depicted by the large posters on the wall. Dr. Ton Tran answered questions on Hepatitis. A question was: Why is Hepatitis C not on the screening program? This may be possible at furture sessions using HCV Rapid test, said Albert Rodriguez, tester from UCSD Antiviral Research Center. Although the number of persons screened was modest, each one was carefully attended to, and most gladly received flu shots administered by

nurse Hue Wang. After a warm and tasty lunch with vegetarian fare, the outreach at Tzu Chi continued with flu vaccinations lasting until 5 PM. We thank Tzu Chi for the opportunity to learn more about the organization



## Spring Health Fair at the Vietnamese Federation of San Diego By Binh Tran, Pharm.D.

On February 9th from 10 AM to 2 PM., a week after the health screenings at Mira Mesa Park and Recreation Center on the 2<sup>nd</sup> of the Lunar New

Year, the Asian Pacific Health Foundation (APHF) collaborated with nearly all the APhA-SC student groups at the Skaggs School of Pharmacy and Pharmaceutical Sciences to perform the annual Spring Health Fair at the Vietnamese Federation of San Diego.

This was the largest group of VA Hospital preceptors and SSPPS student pharmacists that we have seen during the eight years of collaboration with the school. The attendees were very impressed by the number of volunteers at the



many stations providing free screening and counseling. Although attendance was somewhat less than in previous years due to concurrent Lunar New Year and temple

celebrations, many people came as early as 8:30 AM when the teams were setting up the stations. Sang Van, PhD, Chief Scientific Officer of Annam Pharma, Inc. a biotech company in Sorrento Valley opened the door at 10:00 a.m.. On Binh's request, Sang, a UCSD alumnus, spoke to the students and pharmacists about his background in biochemistry and interest in starting the R & D ANNAM in drug discovery and drug delivery using novel drug delivery technology as the foundation.

After registration, attendees went to the Hypertension, Diabetes and Cholesterol stations to be checked. In between, they visited the self-care stations to be informed on Gastro-enterology

reflux disease, cold and flu symptoms, and other conditions. Bone densitometry was performed by Dr. Khoa Nguyen, acupuncturist and Vice chair of the APHF, next to the medical consultation station where Dr. Ton Tran spoke with patients on their disease status.

Hepatitis B screening was carried out on the majority of attendees, with 32 samples obtained after due consents and permission to utilize the data. Dr. Robert Gish visited all the stations, and spoke with residents and student pharmacists. In the library, the Cervical Cancer team held presentations to assess the knowledge of Vietnamese women on HPV infection.

After lunch from the K sandwiches shop nearby, the fair came to an end but not before several group pictures were taken to mark the day.

## **UCSD/Pfizer Oncology Fellowship**

Congratulations Dr. Joanna C. Masters for completing the UCSD SSPPS/Pfizer Fellowship.

The UCSD/ Pfizer fellowship is a two-year program for PharmD. Fellows are engaged in clinical and research activities that include co-authorship of papers, working as a team in the Moores Cancer Center and the UCSD Medical Center Oncology and BMT services, with the Pfizer Research Unit, and attending or presenting at scientific conferences.

In addition, Fellows have teaching opportunities that include Pharmaceutics, and select areas in Principles of Pharmacology and Physiology and Contemporary Topics in Pharmacology. More specifically, Fellows are involved in developing programs in the pharmaceutical sciences research in quantitative pharmacology, drug discovery and development in clinical oncology.

Joanna describes her experience as follows.

"Some of the most important and most unique aspects of the fellowship centered around the diversity of exposure and experiences that were offered. I was trained to better understand the broad scope of the ever-changing field of oncology, from clinical practice at UCSD medical and cancer centers to translational research to development of novel therapeutic agents in Pfizer's oncology business unit.

This allowed for a dual perspective from both an academic and industry viewpoint. Further, there was a large degree of multi-disciplinary experiences that provided insight beyond that of a

clinical or research pharmacist, such as rounding with physicians and nurses, rotating with clinical trials coordinators, serving on a protocol review board, and of course, meeting the patients themselves.

I was fortunate to have fantastic resources ranging from UCSD Extension courses to conference discussions at the annual ACCP meeting to handson training on various software programs commonly used for population pharmacokinetic and pharmacodynamic modeling, all of which included interaction and mentorship with experts in the field.

These provided skills useful not exclusive to oncology research, but applicable to any therapeutic area in which a clinical pharmacologist or pharmacist may seek to make an impact. An added advantage was the opportunity to stay connected to SSPPS students and faculty through leading workshops and participating in faculty research.

Overall, the fellowship was extremely rewarding and provided an important foundation in addition to my pharmacy education at SSPPS to propel me into a clinical pharmacology career as a young professional."

Joanna is the sixth fellow that graduated from the SSPPS/Pfizer fellowship program, and is currently working at Pfizer in clinical pharmacology.

## **Research News**

## Establishment of the Center for Drug Discovery Innovation (cDDI) as an organized Research Unit at UC San Diego

On December 3, Executive Vice Chancellor Suresh Subramani and Vice Chancellor for Research, Sandra A. Brown announced the establishment of the Center for Drug Discovery Innovation (cDDI) as an Orgainized Research Unit. Michael K. Gilson, Professor and Chair in Computer-Aided Drug Design at the Skaggs School of Pharmacy and Pharmaceutical Sciences and Thoma Hermann, Associate Professor of Chemistry and Biochemistry, will serve as founding co-Directors.

"The cDDI will foster innovation by stimulating exciting new approaches to the challenges of drug discovery within an academic research environment. The cDDI will be a resource assisting UCSD faculty engaged in drug discovery projects anywhere on campus. Research outputs will include advanced computational design methods and sytems pharmacology tools and databases; drug delivery platforms; pharmacogenomics insights and integration of clinical and drug-related databases; crystal structure of therapeutically relevant macromolecules; novel drug targets and assay technologies; and bioactive compounds for use as probes, development leads and candidate drugs."

**Dr. Jonathan H. Watanabe** and colleagues Drs. Mark Bounthavong, Timothy Chen, and John P. Ney recently published their article "Association of Polypharmacy and Statin New-User Adherence in a Veterans Health Administration Population: A Retrospective Cohort Study" in Annals of Pharmacotherapy in October 2013. The authors evaluated the linkage between increasing number of active prescriptions at baseline and adherence of a statin added to their medication regimen in Veterans. In this study, the authors found that patients with more active prescriptions at the start of statin therapy had improved statin adherence over the first year of use. This suggests that clinicians should focus on appropriateness of medication use rather than quantity of medication use when initiating therapy. Appropriateness of use should always incorporate drug interaction and adverse reaction considerations.


Below is an excerpt from the article:

"There was a statistically significant trend of increasing proportion of adherent participants as baseline medication count grew (P value < .001). The analyses adjusted for influential characteristics (egs. age, comorbidities, BMI, baseline lipids, etc.) further demonstrated that statin adherence was increased by 4%, 7%, 10%, and 14% for the 6 to 10 medication count, 11 to 15 medication count, 16 to 20 medication count, and >20 medication count groups, respectively, in comparison with the reference 1 to 5 medication count group (P < .001 for all comparisons). An adherence threshold

of 90% provided consistent evidence of improved adherence as number of medications increased (P < .001). Conclusions: Increased medication count at baseline was associated with improved adherence for new users of statins."
